The Moot Court Board organizes four intraschool competitions: The Domenick L. Gabrielli Appellate Advocacy Competition, the Donna Jo Morse Client Counseling Competition, the Donna Jo Morse Negotiations Competition, and the Karen C. McGovern Senior Prize Trials. Additionally, the Board facilitates seven interschool competitions involving appellate advocacy, trial advocacy, client counseling, and negotiations. The Moot Court Board also sponsors and hosts the Domenick L. Gabrielli National Family Law Competition. This year seventeen teams, representing law schools from across the United States, competed. First year students participate in the program in a variety of ways, but do not compete. 2l and 3L may participate and compete in all programs. Moot Court Board members are selected through a competitive election process by the outgoing board.

Pro Bono

Pro Bono Program Albany Law School students are at the core of the school's growing and evolving Pro Bono Program. The Office of Student Affairs and a full-time Pro Bono Coordinator work closely with students, community partners, and faculty to broaden the scope and range of pro bono learning opportunities. The student-run Pro Bono Society allows students to work in small groups under the supervision of a community partner and with the leadership of a student project director. Each individual project is led by a student project director who works closely with his or her community partner to develop projects, delegate service assignments and schedule and conduct training. The community partner supervises the legal or law-related work and works with the student project director to develop meaningful, appropriate, and engaging service learning opportunities. Each project has a faculty advisor to assist the project directors in realizing their vision and meeting their goals. The Pro Bono Coordinator provides institutional and program support. Law Days The law school is committed to being a good neighbor and supporting the Albany community. To that end, several times a year the school holds community service days. Each day has a theme, which targets a particular underserved community. We create a program of presentations on subjects pertinent to the community, assemble a team of volunteer attorneys to provide free consultations, enroll a keynote speaker and invite the community in for a program that includes a free lunch. Past audiences have included veterans, seniors, and special needs families. In March 2015, we hosted what we believe to be the first law day for the LGBT community - a great success that was attended by over 350 persons. Future themes being discussed include law days for women and animal rights. Free PASS Free Private Attorney Student Support (Free PASS) is a one-time opportunity for students to work with a private attorney by researching a specific area of law for the attorney's pro bono case. Students learn from an attorney working in a private practice while making important connections in the legal community. Pro Bono Society Projects The Pro Bono Society's current projects include the following: • Attorney for the Day/ Tenant Advocacy Students work with the Legal Aid Society for Northeastern New York and the Albany County Bar Association to assist pro bono attorneys who volunteer in landlord/tenant court by providing brief advice to pro se litigants facing eviction. Students help by interviewing clients and organizing client documents for the attorney. • Family Court Help Desk Project Student volunteers help lawyers with the Albany County Bar Association who are assisting pro se litigants in Family Court. Students provide legal information, assist pro se litigants with their court forms, and conduct intake questionnaires. • Health & Human Rights Project Students are providing research and drafting educational modules on human rights and health concerns that arise in prisons around the world, such as the spread of disease in inmate populations in Latin American. • Immigration Assistance Project This project gives students the opportunity to provide legal information to immigrant detainees in Albany County Jail. Last year, ICE issued a directive on Facilitating Parental Interest in the Course of Civil Immigration Enforcement Activities. The purpose of this directive is to ensure that parental rights of immigrant parents and legal guardians are not disrupted when a parent is detained and placed in removal proceedings. • Labor Law & Worker's Rights Project Students work with the Worker Justice Center and the Social Justice Center to provide legal information to non-unionized laborers as to their rights regarding protected concerted activity, wage theft, and other issues. • LawHelp Project After completing a training to become a "live chat specialist" with LawHelpNY.org, students respond to instant messages by providing website users with legal information and assisting them in locating the forms and documents they need to address their legal issue from their own personal computers in three-hour weekly shifts. • Matrimonial & Family Law Project Through the Legal Project's, and the Legal Aid Society's pro se Divorce Clinics, students provide direct assistance to pro se litigants in uncontested divorces with filling out divorce forms. Clinics usually occur twice each semester. • Prisoners' Rights Project Students work with Prisoners' Legal Services (PLS) to: review medical and psychiatric research to assess the impact of incarceration on juveniles; review article 78 petitions to seeking review of decisions by the Department of Correctional Services on issues such as loss of good time, and extended solitary confinement; transcribe tapes to spot legal issues that PLS can assist inmates with. . Veterans' Rights Project Students assist attorneys who provide direct pro bono assistance to veterans and their families. Specific tasks include helping homeless veterans, organizing Veterans' Law Day programs, and helping veterans and their families get access to legal services. In collaboration with the Legal Aid Society of Northeastern New York, students participate in the Wills for Heroes program, and the VAMC legal clinic.
